Cover letter to application -

As you have expressed a desire to be an Elder at DCC, we ask that you complete the attached application. The application is designed to obtain information necessary for your review process for the position.

We at DCC examine Elder candidates in light of scripture and utilize both congregation members and the Elder Council to do this. The congregational aspect of the review is completed in two ways. First, the Leadership Commission is designated by the constitution and appointed by the Elder Council to carry out the administrative aspects of the process and the initial review of the application. This includes ensuring the application is fully completed, contact of personal references, affirmation of membership and planned regular giving practice (not amount), as well as meet with the candidate for an interview and time of prayer.

Second, the congregation is involved via the constitutionally directed four week posting and review process.

Upon recommendation of the Leadership Commission, the Elder Council will meet and examine you based on scripture and your answers on the application. The Elders will make a determination and forward approved candidate names for the above-mentioned congregational review.

All application information will be treated with confidentiality. All Leadership Commission members and Elders involved in the application/evaluation process have been instructed regarding the need to maintain confidentiality for the process and have agreed to do so.

By your completing and submitting this application for consideration, you agree that all information can be used by the Leadership Commission and Elders to determine your qualifications for the position.
